## Announcement – Regulated information

Public Power Corporation S.A. ("PPC" or the "Company") announces that in the context of the announced Own Share Buyback Program, on 04.07.2022, acquired through the Athens Stock Exchange 20,000 own shares at a weighted average price of € 5.1091 per share, of an aggregate value € 102,182. Such acquisitions have been effected through the Athens Exchange member PIRAEUS SECURITIES S.A.. Following the abovementioned purchases, PPC holds 1,735,796 own shares, which correspond to 0.4544% of the Company's total shares.

It is reminded that – as the Company has already informed the investor community through its announcement dated 24.12.2021 – purchases of Own Shares are being made pursuant to the Decision dated 04.06.2021 of the General Meeting of Shareholders and the Decision dated 21.12.2021 of the Board of Directors of the Company. The purchases of Own Shares are being conducted to the extent they are considered beneficial to PPC and subject to the available liquidity of the Company, as well as to market conditions.
